**THE ORGANIZATION PROVIDES SIX WEEKLY SESSIONS OF OVERNIGHT CAMP ON OUR PROPERTY LOCATED IN THE HOCKING HILLS IN ROCKBRIDGE, OHIO CALLED CAMP WYANDOT. IN 2014, 477 YOUTH WERE IN ATTENDANCE AT OUR SUMMER CAMP PROGRAM OF WHICH 397 YOUTH PAID THEIR OWN WAY AND 80 YOUTH ATTENDED ON A SUBSIDIZED PROGRAM OR RECEIVED A CAMBERSHIP. FOUNDED IN 1928, CAMP WYANDOT IS A FUN, EDUCATIONAL, AND NURTURING PLACE WHERE ALL CHILDREN AGES 7-18 FEEL A SENSE OF BELONGING. AS EVIDENCED BY A RETURNING CAMPER RATE OF ABOUT 60%, WHICH IS HIGHER THAN THE NATIONAL AVERAGE. WITH A TRAINED STAFF OF 26, KIDS ENJOY AND BENEFIT FROM A QUALITY CAMP EXPERIENCE IN A SAFE AND SUPPORTIVE ENVIRONMENT.**
